



30 DAY TEST DRIVE

RULES & DETAILS

- Buy any Bestop Soft Top (excluding Replace-A-Tops/RATs) from a participating Bestop dealer.
- If at any point within 30 days of purchase you are not happy with your top, you may return the top to the original dealer with your original sales receipt and completed 30-Day Test Drive Return Form.
- The dealer will refund the purchase price, including tax.

DETAILS

- Offer applies to any Bestop soft top. Consult full list of qualifying soft tops.
- Offer excludes Bestop Replace-A-Tops (Twill, Sailcloth, OEX and Standard).
- Customized and Premium Colors tops are not covered by 30-Day Test Drive.
- The Bestop soft top must be returned with its original packaging, with all hardware, within 30 calendar days of the official purchase date displayed on the sales receipt. Online order returns must be postmarked within 30 days of original purchase.
- This offer is available only to the original purchaser and is non-transferable.
- Consumer receives refund amount equal to price of soft top plus tax. Installation/removal and shipping charges are non-refundable.
- Both online and brick-and-mortar store purchases are eligible for 30-Day Test Drive.
- Consumer may try 30-Day Test Drive as often as they like. If you don't like one top, you may return it and get another top to Test Drive, provided that it is purchased within the promotional window. You may only test drive one soft top at a time.
- Financed tops thru Bestop.com are not eligible for 30-Day Test Drive.
- Bestop and authorized Bestop dealers are not responsible for any alterations made to vehicle in order to install top (e.g., drilled holes)
- 30-Day Test Drive valid only in United States, including Hawaii and Alaska.

RETURN PROCESS

- Consumer must return soft top to original place of purchase.
- Consumer must provide original sales receipt.
- Sales receipt must display date of purchase.
- Consumer must provide completed 30-Day Test Drive Form with receipt.
- FOR BESTOP DEALERS: All returned tops must have a corresponding return receipt and completed 30-Day Test Drive Form in order for Bestop to record return and deliver credit for return.
